

KIDS SUMMER SKILLS CAMP AGREEMENT

This Summer Skills Camp Agreement (the "Agreement") is entered into by and between Time Together, LLC dba Sensory Seekers, located at 102 Derry Road, Hudson, NH and 85 Manchester Street, Concord, NH (hereinafter referred to as "Camp"), and [Parent/Guardian], the parent(s) or legal guardian(s) of the child (hereinafter referred to as the "Guardian(s)") of the child (hereinafter referred to as the "Camper").

2. DATES AND HOURS OF OPERATION The Summer Camp will run from June 30th, 2025 to August 22, 2025 on a weekly basis. The Camp will operate between the hours of 8:30 am and 3:00 pm.

3. PAYMENT AND FEES The total fee for the Summer Camp program is \$225/week (unless otherwise noted) and is due in full 14 days prior to camp start date. This fee includes the following:

- Camp activities
- Camp t-shirt and supplies
- Sensory gym play experience
- Specially trained staff in child education
- NOTE: Meals/snacks not included

4. REFUND POLICY

- Cancellations made within 14 days of camp start date are subject to the full cost of the camp, regardless of reason. Otherwise, subject to non-refundable \$125 deposit after registration is confirmed.
- Sensory Seekers reserves the right to cancel any portion of the camp based on registration, staffing or other concerns. A refund will be given in this situation.

5. CAMPER CODE OF CONDUCT The Camper is expected to follow all rules and guidelines set by the Camp. These include, but are not limited to:

- Respect for staff, fellow campers, and camp property
- Participation in camp activities
- Following instructions provided by camp staff

Failure to follow these rules may result in the Camper being sent home early at the discretion of the Camp.

6. HEALTH AND MEDICAL INFORMATION The Guardian(s) agree to provide complete and accurate health and medical information about the Camper. This includes any allergies, medications, or pre-existing conditions. The Camp will take all necessary precautions to ensure the Camper's safety and well-being.

- **Emergency Medical Treatment Authorization:**
The Guardian(s) hereby authorize the Camp staff to seek emergency medical treatment for the Camper in the event that they are injured or require medical attention.

7. LIABILITY AND ASSUMPTION OF RISK The Guardian(s) acknowledge that there are inherent risks associated with participation in the camp activities, including but not limited to: physical activities, outdoor games, and other camp-based programs. The Guardian(s) voluntarily assume all risks, known and unknown, and agree to hold the Camp, its staff, and affiliates harmless from any liability arising from the Camper's participation.

8. TRANSPORTATION The Guardian(s) are responsible for transportation to and from the Camp. If transportation is provided by the Camp, the Guardian(s) agree to adhere to the specified drop-off and pick-up times. Additional fees for late pick up apply as follows: \$10 for every 15 minutes late after designated pick up time.

9. PHOTOGRAPHY/VIDEOGRAPHY CONSENT The Camp may take photographs or videos of the Camper during their time at the Summer Camp for promotional and marketing purposes. By signing this Agreement, the Guardian(s) consent to the use of the Camper's image in any media produced by the Camp. If the Guardian(s) do not wish for the Camper's image to be used, they must inform the Camp in writing prior to the start of the program.

10. TERMINATION OF AGREEMENT The Camp reserves the right to terminate this Agreement and dismiss the Camper from the program at any time for failure to comply with the rules, misconduct, or other reasons that may pose a risk to the safety or enjoyment of the Camper or other participants.

11. ENTIRE AGREEMENT This Agreement contains the entire understanding between the parties and supersedes any prior or contemporaneous agreements, representations, or communications between the parties. Any amendments to this Agreement must be in writing and signed by both parties.

12. SIGNATURES By signing below, the Guardian(s) agree to the terms and conditions outlined in this Agreement.

13. CAMP WAIVER AND RELEASE OF LIABILITY

By signing this Agreement, the Guardian(s) of the Camper hereby acknowledge, understand, and agree to the following waiver and release of liability:

A. Assumption of Risk The Guardian(s) understand and acknowledge that the Camper's participation in the activities at [Camp Name] (the "Camp") carries certain inherent risks, including but not limited to physical injury, accidents, or illness, which may result from participation in physical activities, outdoor sports, or other camp programs. These risks may include, but are not limited to:

- Injuries resulting from falls, collisions, or other accidents
- Exposure to extreme weather conditions or environmental hazards
- Illness from foodborne or airborne pathogens
- Injuries from equipment malfunction or improper use

B. Release of Liability The Guardian(s) hereby release and discharge the Camp, its directors, employees, agents, volunteers, and affiliates from any and all claims, liabilities, or causes of action arising out of or related to any injury, loss, damage, or accident that may occur during the Camper's participation in Camp activities. This release includes any claims arising from the negligence or other acts of the Camp and its staff.

C. Indemnification The Guardian(s) agree to indemnify, defend, and hold harmless the Camp and its staff from any and all claims, liabilities, or expenses, including attorney fees, arising out of or related to the Camper's participation in Camp activities, including any claim for injury, illness, or damages caused by the Camper's actions, negligence, or failure to comply with the rules and regulations of the Camp.

D. Emergency Medical Treatment The Guardian(s) authorize the Camp to seek emergency medical treatment for the Camper in the event of an accident, illness, or injury, and agree to be responsible for all costs associated with such treatment. The Guardian(s) also understand and acknowledge that the Camp does not provide medical insurance and that it is their responsibility to carry personal health insurance for the Camper.

E. Acknowledgement of Waiver The Guardian(s) acknowledge that they have read, understood, and voluntarily accept the terms of this waiver and release of liability. They understand that by signing this Agreement, they are waiving any right to sue or hold the Camp or its staff liable for injuries or damages that occur during the Camper's participation in Camp activities.

F. Minor's Consent If the Camper is under the age of 18, the Guardian(s) further agree that they have the legal authority to sign this Waiver and Release of Liability on behalf of the Camper and that the Camper will abide by the rules and guidelines set by the Camp.
